

GENERAL CONDITIONS RT2025

General provisions

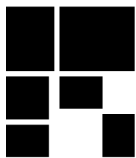
1. These rules define the general conditions of participation in the Call for the Revela'T Festival 2025 (hereinafter: Call)
2. The contest is organized by the Fotogràfica EspaiFoto Association. C/Riera de Targa 47, 1st floor, 08339, Vilassar de Dalt, Spain.
3. Participation in the Call is subject to a registration fee.
4. The purpose of the Call is to select three projects, which will be exhibited at the Contemporary Analogue Photography Festival, Revela'T 2025.

Conditions of participation in the Contest

1. Photographers of any nationality, origin, or place of residence who work in the field of chemical and analogue photography may participate.
2. This year's theme is "**I've seen things you wouldn't believe...**" and the submitted projects must have some connection with it.
3. Each submitted project counts as one entry. Each photographer may submit more than one entry.
4. Projects authored by duos or collectives may also be submitted.
5. The works included in the Project must be authored by the person or persons submitting them in the case of duos and collectives. Under no circumstances may they have third-party rights.
6. Each participant in the Call agrees that the Organizer may use their email address for informational purposes (Newsletter).

Project submission

- Projects must be submitted before November 10, 2024.
- Projects must be submitted through PICTER, which is linked to the www.revelatfestival.com website.

- The participant must follow the registration process in accordance with the website form. The information related to the participant and their project included in the form must be as accurate as possible.
- The fee to submit a project to the Call is €10 for Friends of Revela't and €20 for the general public.
- The participant is entitled to receive an invoice by sending the necessary details via email to espaifotografic@gmail.com.

Project evaluation

1. The deadline for submissions is 10.11.2024.
2. The jury members can be found on our website and on Pictet.
3. The jury's decisions are final and non-appealable.
4. The jury is not required to justify its decisions or report on the development of its deliberations.
5. It is highly recommended that projects be submitted in English to be properly evaluated by the international jury. They can also be submitted in Spanish/Catalan or French, but in these cases, automatic translation will be applied.

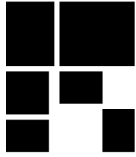
Winners

- National and International visibility and promotion
- FULL PASS and access to the exclusive BRUNCH and dinner with authors
- Inclusion in the festival program and international promotion
- Meeting with industry professionals during the Main Weekend

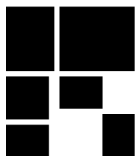
- All participants will have the opportunity to exhibit their project in a digital projection throughout the month of the festival, which will take place in the same space as the rest of the exhibitions. By registering in the form and giving your consent, your project will automatically become part of the digital projection.

Final provisions

- Three projects will be selected by the Jury. Other authors who have scored well may be contacted by the Organization for the opportunity to exhibit at the Festival. In this case, the costs of production or transport of the project will not be borne by the Organization.
- The Organizer does not foresee additional remuneration related to the organization of the exhibition.
- The production and transportation of the winning projects are decisions that will be made by the Organization, which has the final say on the matter. The organization usually works with collaborations in the production process, and the value of the collaboration will be considered.
- The Organization reserves the right to decide the lab, printer, or transport chosen for the winning projects.
- The projects produced by Revela't will become part of the festival's traveling catalog for 2 years. The works will have the opportunity to travel to other galleries and festivals with a fee established by mutual agreement between the author and the organization.
- Authors will have the opportunity to sell their work at the festival. Only the work exhibited at Revela'T 2024 may be sold. The organization will not charge a fee.

- Winners will have a two-night stay covered in a host family or hotel. This stay will be during the Main Weekend of the festival in May 2024.
- Submissions that do not meet the requirements will not be considered. Under no circumstances will the Call registration fee be refunded. Please read the selection criteria before applying.
- Announcements and information related to the Call will be published on our social media (Instagram: [revelatfestival](#)) and through our newsletter and website ([revelatfestival.com](#)).
- All correspondence and inquiries related to the Call must be sent by email to espaifotografic@gmail.com.
- The Organizer reserves the right to suspend, change, or extend the Call.
- The Organizer has the right to cancel the Call without giving any reason and not select a winner. In this case, the registration fee will be refunded.
- Those who do not meet any of the requirements established in these Rules or provide false information will be automatically eliminated from the Call.
- Participation in the Call (submission of the Project) implies acceptance of the content of these Rules.
- In accordance with Law 34/2002 on Information Society Services and Electronic Commerce (LSSI) and Organic Law 15/1999 on Data Protection (LOPD), the Fotogràfica EspaiFoto Association guarantees the security and confidentiality of the personal data provided in this entry. The user is informed and consents to the incorporation of their data into the existing automated files at the Associació Fotogràfica EspaiFoto and the automated processing of them, for the sending of news of interest about its activities. In any case, the Associació Fotogràfica EspaiFoto ensures the exercise of rights in the terms established by current legislation. - Revela'T Festival reserves the right to cancel exhibitions or scheduled events if it is perceived that the application has somehow discredited the Festival. If for any reason the selected applicant cannot exhibit as planned, they must notify the Revela't Festival at least 2 months in advance before the launch of the Festival in May 2024.
- The Organization reserves the right to resolve any unforeseen circumstances in these rules and to make changes to the planned program due to force majeure.
